Before you agree to participate, please review the details below.

1. Booth is 10' x 10' space. Fee covers the 2-day rental of your tent, 2 tables, 2 chairs table cloths, and rental of shared 3-compartment sinks. Large shared eating area near entertainment stage with canopy.
2. Each booth **MUST** be open during the Festival hours: **Saturday, August 10th: 11:00 am to 8:00 pm; and, Sunday, August 11th: 11:00 am to 4:00 pm.**
3. Each vendor must provide their own volunteers for their booth.
4. Each vendor must provide their own supplies for their booth such as plates, cups, bowls, chopsticks, forks, napkins, straws...etc.
5. Each vendor must provide their own equipment such as rice cookers, chafing dishes, cooler... etc.
6. One parking space will be provided to each vendor in L.A. City Lot 7, on John Aiso and First Street which is the Festival site. Parking passes will be handed out at the HEALTH SEMINAR on July 28th.
7. All vendors **MUST** send at least 1 representative to a **MANDATORY** seminar on **Sunday, July 28th, 2019** from 2:30 pm to 4:00 pm at the Koban. We will go over Health Department rules and regulations.
8. Any items left behind in the booths after the event are not the responsibility of the LATF organizers.
9. To cancel this application a **written notice** must be received by July 5th, 2019 for a 100% refund. Cancellations after July 5th, 2019, payment will not be refunded.
10. Each vendor must complete and submit COMMUNITY EVENT TEMPORARY FOOD FACILITY APPLICATION. Paperwork is required by the Los Angeles County Health Department.
